Western Coalfields Limited (WCL), a Mini Ratna Company is a Subsidiary Company of Coal India Limited under Ministry of Coal, Govt. of India with its headquarters in Nagpur, Maharashtra. WCL is a coal mining company with its operations being done through 10 areas having highly mechanized opencast and underground coal mines spread over the states of Maharashtra (in Nagpur, Chandrapur & Yavatmal districts) and Madhya Pradesh (in Betul and Chhindwara districts).

WCL invites applications from eligible Indian nationals **THROUGH ONLINE APPLICATION MODE** for regular appointment to the posts of Mining Sirdar, T&S Grade-C and Assistant Foreman (Trainee) (Electrical)/Electrical Supervisor, T&S Grade- C required for its Underground (UG) and Opencast (OC) mines as per details given below. The selection will be done on the basis of Computer Based Test (CBT).

* As per the guidelines of Ministry of Social Justice and empowerment, GOI & CIL HQ Office Memorandum no. CIL/C5A/MP&IR/RPwD/75 dated 27.09.2024, the post of Mining Sirdar does not fall under the identified list of positions for PwBDs, hence reservation for PwBD candidates is not applicable for it. (2) MINIMUM QUALIFICATION, ELIGIBILITY CRITERIA AND SYLLABUS

Note:

- i. Candidates possessing other equivalent qualifications approved on that behalf by the Central Government or a higher qualification in the respective discipline are also eligible to apply.
- ii. For the post of Mining Sirdar, T&S Grade-C, candidates possessing higher statutory competency certificates issued by DGMS are also eligible to apply.
- iii. Degree/Post Graduate/Diploma qualifications acquired through distance learning/part-time or their equivalent shall not be considered.
- iv. As the above mentioned vacancies are for both UG and OC mines, candidates having restricted competency certificates will not be eligible for the above posts.

(3) MINIMUM & UPPER-AGE LIMIT

- i. The age of the applicant should not be less than 18 years as on the cut-off date.
- ii. The Upper-age Limit is 30 years for Unreserved (UR) & EWS category candidates as on the cut-off date.
- iii. However, relaxation in the upper age limit of 30 years will be given to certain categories which are mentioned below (**Table 4**):

- iv. **The Date of Birth as recorded in the Matriculation/Secondary School Examination/Equivalent Examination certificates issued by Central/ State Board only will be accepted.** No subsequent request for change in the Date of Birth will be entertained.
- v. The cut-off date will be the last date of filling the online application i.e. **10.08.2026**

(4) PAY SCALE AND TRAINING/PROBATION PERIOD

In addition to the basic pay mentioned above, other allowances such as Dearness Allowance, attendance bonus, special allowance, HRA, Transport subsidy, Medical Facility etc. as per the provisions of NCWA XI are also admissible. After successful completion of training/probation, further career growth will be as per the prevailing respective cadre schemes & rules.

(5) RESERVATION

- Reservation of SC/ST/OBC (NCL)/EWS/PwBD/ESM will be followed as per applicable Acts, rules, guidelines, notifications and amendments issued by Govt. of India from time to time.
- The total number of vacancies and the reserved vacancies are provisional and may vary according to the actual requirements. The reservation under various categories will be as per prevailing Government of India's guidelines at the time of finalization of results.
- All those candidate(s) seeking reservation/ relaxation benefits available for EWS/ SC/ ST/ OBC (Non-Creamy Layer)/PwBD/ ESM must ensure that they are entitled to such Reservation/ Relaxation as per eligibility prescribed in the Rules/ Guidelines. They should be in possession of all the requisite certificates in the prescribed format in support of their claim as stipulated in the Rules/ Guidelines. Prescribed formats are enclosed as **Annexure III** for ready reference along with this Employment Notification, aspirants may find appropriate one as applicable/ suitable for claiming Reservation/ Relaxation benefits as per entitlement.
- Candidate(s) who wish to be considered against reserved vacancies and seek other concessions applicable to the reserved categories must submit requisite certificate(s) on the prescribed proforma from the competent authority for availing such reservation.
- A candidate seeking appointments on the basis of reservation to SC/ST/OBC (NCL) must ensure that he/ she possesses the Caste/Community certificate (**Applicable for Centre List only**).
- Caste certificate in the prescribed proforma enclosed as **Annexure III** has to be produced by the candidates seeking reservation as SC/ST/OBC (NCL) from the Competent Authority indicating clearly candidate's caste, the Act/order under which the caste is recognized as SC/ST/OBC(NCL) and the

village/town that candidate is ordinarily a resident of. The candidates who have been issued caste/category certificate from Maharashtra state need to submit their caste validity certificate issued by Scrutiny Committee in addition to the caste certificate for availing the benefits of reservation. A candidate will be eligible to get the benefits of community reservation only in case the particular caste to which the candidate belongs is included in the Central List of reserved categories issued by the Govt. of India

- vii. Vacancies reserved for OBC category are available only to OBC candidates belonging to Non- Creamy Layer (NCL) category. OBC(NCL) candidates must ensure that he/she does not fall in the Creamy Layer category as on the Cut-off date. Candidates applying against vacancies reserved for OBC should note that they are required to upload a valid non-creamy layer Caste certificate and Self Declaration as mentioned in **Annexure III** along with the Application and also submit the same at the time of document verification in support of their belonging to OBC community in the central list of OBC issued by Govt. of India, in the prescribed format for this purpose.
- viii. SC/ST/OBC (NCL)/EWS candidates, who are selected on their own merit without relaxed standards, will not be adjusted against the reserved vacancies. Such candidate(s) will be accommodated against the unreserved vacancies earmarked for UR category.
- ix. SC/ST/OBC (NCL)/EWS candidates who qualify on the basis of relaxed standards viz. age limit, prescribed minimum qualifying marks in CBT etc., irrespective of his/her merit position, will be counted against reserved vacancies and not against UR vacancies.
- x. The nature of reservation for ESM & PwBD is Horizontal- A General category ESM/PwBD will be adjusted against UR, OBC-NCL category ESM/PwBD will be adjusted against vacancies reserved for OBC-NCL and ESM/PwBD candidates belonging to SC/ST caste category will be adjusted against vacancies reserved for SC/ST candidates.
- xi. Ex- Servicemen who have already secured employment in Government Jobs in civil side in Group C & D posts on regular basis after availing of benefits of reservation given to Ex-Servicemen for their re-employment are not eligible for reservation in ESM category and Fee Concession. However, he/she can avail the benefits of reservation as Ex-servicemen for subsequent employment if he/she immediately after joining civil employment, given self-declaration/undertaking to the concerned employer about the date wise details of applications for various vacancies for which he/she had applied for before joining the initial civil employment as mentioned in the OM No 36034/1/2014- Estt. (Res) dated 14/08/2014, issued by DOP&T.
- xii. Candidates belonging to Economically Weaker Section (EWS) will have to submit a copy of valid Income & Asset certificate issued by the competent authority as per OM No. 36039/1/2019-Estt (Res) dated 31.01.2019 of DoPT, Ministry of PPG&P, Govt. of India on the basis of gross annual income of Financial Year 2025-26.
- xiii. Degree of benchmark disability for reservation and competent authority for issue of disability certificate: - Only such persons would be eligible for relaxation in conditions/reservations in posts who suffer from not less than 40% of relevant benchmark disability. Those Persons with benchmark disabilities (PwBD) who have availed the relaxation and /or reservation and shortlisted for document verification have to submit the original certificate of disability issued by the competent authority as per the prescribed form under chapter 7 of Rights of Persons with Disabilities Rules, 2017. The existing certificates of disabilities issued under the PWD Act 1995 (Since repealed) shall continue to be valid for the period specified therein.

- xiv. In case of Persons with benchmark disabilities (PwBD), the facility of Scribe shall be given/opted for if so desired by the person, if applicable as per the relevant provisions of Act/Rules/Guidelines of Govt. of India (Refer OM F No. 34-02/2015-DD-III dated 29.08.2018 issued by Under Secretary to the GoI, Ministry of Social Justice & Empowerment). Scribe certificate, as applicable has to be produced by the candidate(s) in prescribed proforma enclosed as **Annexure IV** at the time of reporting for CBT.

(6) SELECTION PROCESS

- i. Eligible candidates meeting the minimum eligibility criteria as on the Cut-Off date, as specified in this Notification, will be required to appear for a Computer Based Test for which time, date and venue will be communicated through admit cards issued through the official website/recruitment portal.
- ii. The CBT will be of 100 questions (Part 1 General Aptitude - 20 questions; Part 2 Technical - 80 questions) and each question will carry 01 mark. The duration of the CBT shall be 90 minutes. The test will consist of multiple-choice questions with four options of answer of which one option will be the correct answer. There will be no negative marking for any wrong answer. No marks will be awarded for unattempted questions. The question paper shall be bilingual i.e. in English and Hindi only. However, in case of any error/ambiguity in English and Hindi versions of the question, the English version of the question shall be valid and final.
- iii. Maximum marks of the CBT and minimum qualifying marks for respective category of candidates shall be as mentioned below (**Table 6**):

- iv. Candidates will be allowed to appear in the CBT on the basis of their declaration regarding their eligibility, in the online application. Scrutiny/Verification of the applications with original documents/certificates of shortlisted candidates will be done after declaration of result of the CBT which will be published on WCL website after successful completion of the CBT.
- v. Candidates shall be shortlisted on the basis of marks obtained in the CBT. Such shortlisted candidates will be called for scrutiny/verification of documents/certificates as per merit in the respective category. The zone of consideration for scrutiny of documents shall be 3 (three) times the number of vacancies in each of the categories. The candidates shall have to appear along with a printed copy of the application, original certificates/documents & one set of self-attested photocopy of each certificate/document as per the eligibility criteria notified in this advertisement for scrutiny/verification. If the particulars mentioned in the application/documents regarding age, caste, educational/technical qualification, competency and other details do not match or are not found to be in conformity with the eligibility criteria mentioned in this notification, the candidature of such applicants shall not be considered for empanelment and their candidature shall stand rejected. The date, time and venue for scrutiny/ verification will be notified on the official website of WCL.

The candidates who do not appear for document verification before WCL Authorities on the notified date of document verification/scrutiny, shall also not be considered for final empanelment for appointment.

- vi. After scrutiny/ verification of documents the 'Merit panel' of candidates on the basis of their marks in respective categories will be published, in the order of marks scored, in the official website of WCL.
- vii. In case of a tie in marks obtained in the CBT, it will be resolved first on the basis of Date of Birth (elder being the first) and then by alphabetic order of their first name as appearing in the Matriculation certificate will be considered for deciding the merit position.
- viii. A provisional offer of appointment will be issued to the selected candidates in accordance with their relative merit position and with due consideration of the reservation of posts to the reserved category candidates against vacancies.
- ix. If it is found during the Scrutiny/ Verification, or during the probation period, or even during the course of employment, that the candidate is not fulfilling the criteria of eligibility in any respect, his/her candidature will be cancelled, and appropriate action will be initiated against him.

(7) APPLICATION FEE

Candidates will have to make payment of Application Fees through the Online Mode during filling up of the online application as under (**Table 7**):

- Note 1:** Applications of candidates from Unreserved (UR)/OBC (Non-Creamy Layer)/EWS category without the prescribed fee will not be entertained and summarily rejected. No representation against such rejection would be entertained.
- Note 2:** Application Fee is non-refundable under any circumstances.
- Note 3:** Any tax or Bank charges other than the application fees as prescribed above will be borne by the candidates.
- Note 4:** Application fee will be paid through online mode only. There will be no other mode for payment of application fee. WCL will not be responsible, in case a candidate deposits the fees by any other mode.

(8) GENERAL INSTRUCTIONS FOR CANDIDATES

- i. A candidate can only apply for any one of the two positions notified in the Employment Notification as provided in 'Table 1'. If a candidate applies for multiple positions his/her candidature for recruitment against this notification will be cancelled.
- ii. All qualifications should be recognized by AICTE/ UGC/ appropriate Indian Statutory Authorities.

- iii. **TEST CITIES:** The Computer Based Test will be held in Cities as mentioned in the online application form. Candidates may opt for the Test Cities from the list as per their preference and the same cannot be changed after the online application form is submitted. WCL reserves the right to allocate any Test City or change the Test City opted by the candidate. WCL reserves the right to add or delete any City from the list based on the number of applicants.
- iv. Only those applications which are submitted through the online recruitment portal shall be considered. Applications received through any other modes will not be accepted.
- v. Before applying for a particular post, the candidate must ensure that he/she fulfils all the eligibility and other norms mentioned in the advertisement.
- vi. Before submitting the online application, the candidate must ensure that his/her application is complete in all respects. Incomplete applications will not be accepted.
- vii. Candidates are advised to be careful and ensure that correct and complete details are mentioned in the application and all requisite documents are also enclosed with it before finally submitting the application in the online portal. Any request to update/correct the application after final submission will not be entertained.
- viii. The decision of WCL management regarding eligibility criteria, acceptance or rejection of applications, mode of selection to the post etc. shall be final and binding on all candidates. Mere fulfillment of the required qualification and job requirements will not vest any right on candidates for being called for the CBT/document verification/selection. No correspondence will be entertained from the candidates found ineligible and not called for CBT/document verification.
- ix. Mere issuance of Admit Card to a candidate will not imply that his/her candidature has been cleared by WCL.
- x. No relaxation in the minimum qualification and eligibility criteria prescribed in **Table 3**, is admissible for any category of candidate.
- xi. Minimum qualification acquired through distance learning/part-time or equivalent qualification shall not be considered.
- xii. Candidates should carefully fill up their category (UR/EWS/SC/ST/OBC (NCL)/Ex- Servicemen etc.) in the Application form. Candidates should also upload valid caste/category certificate along with the online application. If a valid caste/category certificate is not uploaded with the application, then the candidate shall be considered as UR candidate only. No request for change of category shall be allowed at a later stage of the selection process.
- xiii. The Caste Certificate/EWS certificate/PwBD certificate submitted by the candidate will be verified from the issuing Authority. The candidature will be cancelled if any of the certificates/qualifications submitted by the candidate are not found satisfactory/genuine at any stage of the selection process.
- xiv. EWS/SC/ST/OBC (NCL)/Ex-Servicemen certificates issued by Competent Authority should either be in Hindi or English.
- xv. Ex-Servicemen must produce the discharge certificate issued by Army/Navy/Air Force of Indian Union at the time of document verification.

- xvi. The candidates must have an active E-mail Id & Mobile number which must remain valid for at least next one year. All correspondence with the candidates shall be done either through registered e-mail id or mobile number (as may be necessary) and all general information shall be provided through WCL website. **However, admit cards will be provided only through the official website/recruitment portal and the candidates will have to download the E-admit card.** The responsibility of receiving, downloading, and printing of application form, E-Admit Card and other information shall be of candidates. WCL will not be responsible for any loss of document due to invalid/ wrong/ incomplete contact details provided by the candidate or for delay/ non-receipt of information.
- xvii. Candidates are advised to apply much before the closing date for submission of Application mentioned in this advertisement to avoid last minute network congestion.
- xviii. WCL will not bear any liability on account of service bond/salary/leave salary/ pension contribution, etc., if any, of previous employment of any candidate already working in Central Govt./State Govt./ Autonomous Body/Public Sector Undertaking/Private Company etc.
- xix. Candidates employed in Govt./Semi Govt./Public Sector Undertaking/Autonomous Bodies are required to produce '**No Objection Certificate**' at the time of Scrutiny/Verification of original documents, if shortlisted and produce relieving order from the Organization in the event of selection, at the time of reporting for joining.
- xx. Selected candidates can be posted in any UG Mine or OC Mine of any Area of WCL and are liable to be transferred to any Area of WCL anytime during their service as may be required.
- xxi. Appointment of selected candidates will be subject to them being found fit in the Initial Medical Examination as per the laid down medical standards of the Company.
- xxii. Selection of a candidate shall be provisional, subject to verification of documents relating to eligibility criteria, character, antecedents and other documents submitted by the candidate and is also subject to his/ her meeting other requirements applicable for appointment under the rules of WCL.
- xxiii. The date of the Computer Based Test and other details will be subsequently informed through the WCL website. Candidates will have to appear at the Centre/ Venue allotted to them by WCL for the CBT. No change in Centre/Venue is permissible and no application shall be entertained in this regard.
- xxiv. WCL management reserves the right to modify/alter/restrict/enlarge/cancel the recruitment process, and revise the number of vacancies, at its discretion without assigning any reasons whatsoever. The decision of the WCL management will be final and no appeal will be entertained in this regard.
- xxv. All future communication/information regarding this recruitment will be made available on WCL website. Candidates are advised to check/visit WCL website (**www.westerncoal.in**) regularly for further updates.
- xxvi. No TA/DA will be paid to any candidate for appearing in the Computer Based Test, scrutiny/ verification of certificates and documents or for joining on being selected except otherwise as provided in this advertisement.
- xxvii. Candidates will appear for the Computer Based Test at the Examination Centre at his/her own risk and WCL will not be responsible for any injury or losses etc.

- xxviii. The Court of Jurisdiction for any dispute will be Honourable High Court of Bombay - Nagpur Bench.
- xxix. In case of any ambiguity/confusion, the English Version of the Employment Notification will be considered valid.
- xxx. In case of any problems faced by the candidates in filling up the online application form they may contact the “**Help Desk**” as mentioned in the **Instructions Page of the Online portal**.

(9) ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT

- i. At the time of Computer Based Test, if a candidate is found guilty of using unfair means or impersonating or misbehaving in the examination hall or resorting to any other unfair means in connection with his/her candidature for the selection; or obtaining support of his/ her candidature by any means, such candidates will be liable to criminal prosecution and will be disqualified from the Computer Based Test. The Company may also debar such candidates from participating in any selection process in the Company in future.
- ii. If it is detected that any candidate has furnished any false information/particulars with regard to his/her qualification, Category/Caste and experience in the Application Form or in any document and/or misrepresented/suppressed any material fact in the application form, for securing appointment, his/her service will be terminated forth with during probation period or even after confirmation of the service.
- iii. Canvassing in any form will be treated as dis-qualification.

(10) HOW TO APPLY

- i. A detailed **Step by Step instructions** to fill the online application form shall be **available therein**. Candidates are requested to follow the same for filling the online application.
- ii. Employment Notification is available in both English and Hindi. Candidates may select either of them at their convenience.
